1. I am 18 years old or older, and I am not under the influence of any drugs or alcohol.
2. I am not allergic to any metals or topical ointments. I am not a hemophiliac (free bleeder), nor to my knowledge do I have any physical, mental or medical condition which would prevent my receiving a tattoo or piercing today, or would affect my well being afterward.
3. I have read all of the aftercare instructions, I understand them and I will follow all written instructions, as well as any additional instructions my artist may provide.
4. I understand that I must cooperate with my artist as my work is accomplished, and that if I make it impossible to accomplish or complete the work, I still owe the full price of the session. In other words, there are no refunds made for being an impossibly-difficult client.
5. I hereby give permission to Iron Anchor Tattoos to use my first name, real or fictitious, and photographic likeness featuring my body artwork in all forms and media for advertising, trade, and any other lawful purposes.
6. Being of sound and sober mind and body, I fully accept any and all responsibilities and consequences of having my tattoo or piercing work done at Iron Anchor Tattoos. I hereby release Iron Anchor Tattoos and any and all employees and agents thereof from any responsibility, liability and consequences that may arise as a result of having my body art work done at Iron Anchor Tattoos.

I agree not to pursue any legal or other action to seek or recover damages, claims, rights including trademark, service mark or copyright of artwork or resultant tattoo or piercing installation, or any other causes of action whatsoever based upon injuries of property, damage to or death of myself, or of any other persons, as a result of my having body art work done by Iron Anchor Tattoos, whether or not Iron Anchor Tattoos was negligent.
8. I agree for myself, my heirs, assigns and legal representatives to hold Iron Anchor Tattoos harmless from all damages, actions, causes of actions, claim judgments, costs of litigation, attorney's fees, and all other costs which may arise from my decision to have body art work done at Iron Anchor Tattoos today.
9. I agree to pay for any and all damages and injuries to persons or property belonging to myself as well as Iron Anchor Tattoos and any and all persons in its employ or association, or to whom it may become contractually obligated, or by operation of law, caused by or resulting from my decision to have body art work done today by Iron Anchor Tattoos.
10. If for any reason I am asked by any employee, officer, owner or agent of Iron Anchor Tattoos to leave the premises, I will comply promptly and without protest or disturbance.
